Jack Korman, FMEC Board Chair, called this meeting to order at 8:00 a.m. and led everyone in reciting the Pledge of Allegiance.

Chair Korman called for any agenda edits or additions. Hearing none, the board voted to approve the agenda for the August 29, 2023, monthly board meeting as presented.

Steve Garbisch, District 3 Director, provided valuable tips for walking safely.

Motion carried to enter Executive Session at 8:12 a.m. During this session, the President & CEO's Performance Appraisal Process was discussed. In addition, an update was provided on pending litigation filed against Freeborn Mower Electric Cooperative regarding a defamation claim and pending litigation resulting from a traffic accident. Motion carried to adjourn the Executive Session at 8:22 a.m. *Minutes have been recorded and are filed at the cooperative office.*

- Scenic Rivers Electric Cooperative SREC had a lineman fatality last week.
- **Nemadji Trail Energy Center** Jim reviewed a letter to support the Nemadji Trail Energy Center (NTEC) project. All board of directors and leadership team members were also encouraged to show support by submitting a letter.

Motion carried to approve the Consent Agenda as presented. This includes approval of the monthly board minutes and executive session minutes from the July 25, 2023, board meeting, the approval of new members, authorization to make payments to estates, the audit committee and treasurer's report, and the safety and management team reports.

Several area legislators joined this meeting at 9:00 a.m. for our annual update designed to build relationships, provide input, and educate about issues concerning the electric utility industry.

FMEC's Dairyland Power Cooperative (DPC) Director, Bill Trygstad, updated the board on the DPC meetings he has attended since our last meeting. He participated at the DPC Manager's Meeting (DMA) as an observer in August and found it very educational. The DPC board meeting's highlights, summary, and financial reports were reviewed.

Angie Kolker, Director of Finance, presented the monthly FMEC financial reports for July 2023, and Bryan Skogheim, Director of Business Development & Energy Solutions, fielded questions regarding the monthly C&I reports.
