POWERING THROUGH: STRATEGIES TO COMBAT MISO'S PROJECTED POWER SHORTFALL

Midcontinent Independent System Operators (MISO) distributes a survey each year that gives an in-depth analysis of the grid's capacity, outlining committed power resources, new capacity opportunities, and potential unavailable capacity. This information is stacked against the current and projected power demands as well as historical data to help determine the projected energy forecast based on trends.

Right now, we are trending in the wrong direction. With the influx of Cryptocurrency operations, electric vehicles, increased cooling demands, manufacturing, and Data Centers, grid planners nearly doubled their 5-year peak load growth forecasts since last year.

This means that next summer, the MISO's northern and central regions could face a 1 GW to 3.7 GW shortfall. #2117200 To put it simply, there will not be enough power generated to meet the demand, which could result in power "blackouts" if swift action isn't taken.

We have seen an ease of supply chain bottle necks, permitting constraints, and labor shortages but there still remains an urgent need for collaboration at State and Federal levels of government to bring new capacity online, coordinate resources for new load additions and slow the pace of resource retirements so that we can prevent this situation from happening.

Freeborn Mower Electric Cooperative, along with our utility partners, are engaging in proactive strategies such as increasing our investments in renewable energy sources, enhancing our grid's infrastructure to handle peak loads more efficiently, and exploring efficient energy solutions. We're committed to not only addressing the immediate concerns but also ensuring a sustainable and robust power system for the future. Our position is to transform these obstacles into opportunities for innovation and resilience, reinforcing our dedication to our members' needs and environmental stewardship.

Before students return to school this fall, don't forget to remind them of important electric safety precautions to take whether they're in Pre-K or headed off to college.

TIPS FOR STUDENTS

- Stay Away from Pad-Mount Transformers: Green, pad-mount transformers contain high-voltage electrical equipment and should never be climbed on. Always keep a safe distance to avoid any risk of electric shock.
- Avoid Utility Poles and Power Lines: Utility poles and power lines are dangerous. #2117200 Teach students to stay away from them, as contact can result in serious injury or worse.
- Don't Overload Electrical Outlets: Overloading outlets can cause electrical fires. Ensure that students

plug in only the necessary devices and keep all cords away from bedding, curtains, or other flammable materials to prevent fire hazards.

- Know What to Do in an Accident Involving Power Lines: If involved in an accident with power lines, it's crucial to stay inside the vehicle unless there is an imminent danger of fire. Call 9-1-1 immediately and wait for help.
- Use Extension Cords Sparingly: Extension cords should only be used for temporary purposes.

 Overusing or overloading them can lead to overheating and potential fire risks. Make sure they are unplugged and stored away when not in use.

By following these essential electric safety tips, students can stay safe and focused on their studies. Have a safe and successful school year!

There are seven cooperative principles that are the backbone to FMEC's daily operations. One of these core principles is Concern for Community, which is why FMEC's Board of Trustees voted to adopt the Operation Round Up® charitable-giving program in 2003.

Operation Round Up® (ORU) is a national program, that's been serving rural communities for over three decades. By simply rounding monthly bills to the nearest dollar, members can make a significant group impact. #1465605 The extra change collected is used to support unmet needs for local community projects and charitable causes within the service area. A few cents from each member may seem small, but collectively, it creates a ripple effect of positive change.

This quarter, FMEC was able to donate \$22,400! These small, but meaningful contributions support a wide range of community needs, such as:

- Food banks and pantries
- Education and youth programs
- Community development projects
- After prom events and school sponsored graduation events
- Public library programs
- And much more!


