## **POSITION TITLE: JOURNEYMAN LINeworker**

### **Objectives**

The Journeyman Lineworker plays a key role in supporting the Cooperative's operations. This position is responsible for ensuring that reliable service is consistently maintained and delivered efficiently. The employee also serves as a primary representative of the Cooperative to both its members and the public.

Reports to: Manager of Operations

### **Responsibilities**

These examples illustrate the various types of work performed in this position. The omission of specific duties does not exclude them if the work is similar, related, or a logical assignment to the position.

- Complies with all safety rules and Cooperative policies.
- Constructs, maintains, and repairs underground and overhead distribution lines, along with performing related operational activities.
- Installs transformers, pole units, services, regulators, including banks and metering on energized or de-energized lines.
- Ensure all assigned vehicles and equipment are operated properly, maintained regularly, and kept in safe working condition.
- Investigates consumer service complaints and outage reports, performing necessary repairs to restore service.
- Participates in the standby rotation for after-hours outages, emergency response, and storm restoration.
- Immediately reports any safety hazards observed whether requiring corrective action by the

- Cooperative or by the consumer.
- Promotes morale, teamwork, and a positive work environment through leadership and example.
- Complies with all applicable rules, regulations, laws and safety practices related to operating assigned vehicles and equipment.
- Supports and advances the Cooperative’s objectives, goals, and programs through professional conduct and engagement.
- Stays informed on Cooperative policies and procedures to effectively respond to consumer inquiries and service needs.
- This position may require work outside of normal business hours.
- Additional tasks may be assigned based on your knowledge, skills, and abilities, or for which you have received training.

## Position Requirements

### Education

- High School Diploma or Equivalent
- Journeyman Lineman Certification

### Abilities and Skills

- Possess a valid Minnesota Class A CDL and current medical card
- Ability to work without direct supervision
- Ability to follow oral or written instructions accurately
- Ability to operate mechanical equipment
- Exhibits strong oral and written communication skills

### Physical Characteristics

Must be able to perform the essential functions of this position with or without reasonable accommodation and must maintain a professional and well-groomed appearance.

### FLSA Status

This is a union position and will be governed by the union agreement. This position is non-exempt under the Fair Labor Standards Act (FLSA). This position is full-time with a minimum of 40 hours per week. Daily timesheets will be maintained.
