Program Details

SCHOLARSHIP AWARD DETAILS:

• Two (2) \$1,000 scholarships are awarded each year. The scholarships are established to assist students pursuing a post-secondary education in an electric utility lineworker program.

ELIGIBILITY:

- Any applicant enrolling in a lineworker program or any applicant who can prove they are
 on a waiting list for the next open enrollment period. Preference would be given to
 FMEC members and residents of Freeborn and/or Mower Counties.
- At the time of application, student must have a 2.5 grade point average and maintain a
 2.5 grade point average during their first term of college.
- No student shall be excluded for race, creed, color, sex, or national origin.
- Applicant must be enrolling in a program leading to a certificate to work in the electrical lineworker field.
- Applications must be received by March 1, 2026.

SELECTION:

• The applications will be reviewed and evaluated, and students will be selected based on the application, the essay questions, and the ability of the student to maintain a 2.5 grade point average during their first term of college.

NOTIFICATION:

• The cooperative will contact students after all applications have been reviewed and selections have been made.

DISBURSEMENTS:

• Full scholarship amount will be disbursed directly to the school and applied to their student account.
