- ❖ Equipment rebate(s) must be **submitted no later than 3 months after purchase date** and must be installed on cooperative's lines.
- ❖ Rebates are in place through December 31, 2022. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Rebates submitted after December 31, 2022, will not qualify if the rebate is no longer offered in 2023.
- ❖ Rebate not to exceed the cost of equipment.
- ❖ Additional eligibility criteria may apply. Contact cooperative for details. Program is subject to change or cancellation without notice.
- ❖ All documentation listed below must be **submitted no later than 3 months after purchase date**.
