# CENTRAL AC TUNE-UP

## ELIGIBILITY AND INSTRUCTIONS

- Hire your own HVAC service contractor and receive a **\$25 rebate as a credit on your electric bill.**
- Hire a contractor of your choice.
- After completing the tune-up, have your contractor fill out the contractor portion below.
- Complete the member information portion below.
- Tune-up must be completed where electricity is supplied by Freeborn Mower Electric Cooperative.
- **The central air conditioner or air-source heat pump must be in operating condition, over three years of age, and not had an AC Tune-up in 2021 or 2022.**
- Rebate submittal must follow the guidelines listed above.
- Program is subject to change or cancellation without notice.
- Program is for tune-ups only; it does not cover the cost for repairs of the air conditioner or heat pump.
- Rebates are in place through December 31, 2023, or until funds are depleted. Funds are limited so members are encouraged to submit as soon as possible.
- Rebates submitted after December 31, 2023 will not qualify if the rebate is no longer offered in 2024.
- All documentation listed below must be **submitted no later than 3 months after improvements are completed.**
