



## AUDIT RECOMMENDED IMPROVEMENTS

### ELIGIBILITY AND INSTRUCTIONS

- Home or farm being improved must be on cooperative's lines
- Rebates are in place through December 31, 2025 or until funds are depleted. Members are encouraged to submit as soon as possible
- Rebate not to exceed the cost of energy efficiency improvements up to \$500. Cost can include material and professional labor. The cost of the audit can not be included.
- Energy efficiency improvements must be recommendations from an audit arranged by your cooperative or a cooperative approved partner.
- The audit must be a comprehensive audit, including a written report.
- The audit report must indicate that the improvement will result in electrical or delivered fossil fuels (LP, oil) reduction or efficiency.
- If another rebate is available, the audit recommended improvement will qualify for only that rebate. For example, if an auditor recommends purchasing an Energy Star Refrigerator, the refrigerator will qualify for our Appliance rebate, not the Audit Recommended Improvements rebate.
- Improvements must be completed within 24 months of the audit date.
- If member has multiple audits performed in a calendar year, only improvements from one of the audits will qualify for this rebate.
- Each member account qualifies for only 1 Audit Recommended Improvement incentive every 5 years, regardless of the number of audits performed and regardless the number of measures implemented.
- Additional eligibility criteria may apply. Contact the cooperative for details.
- Required documentation listed below **must be submitted no later than 3 months after improvements are completed.**
  - ✓ **Submit this rebate form.**
  - ✓ **A dated copy of your receipt or invoice for each improvement**
  - ✓ **A dated copy of audit documentation.**
  - ✓ **Documentation showing improvements have been completed**
