ELIGIBILITY AND INSTRUCTIONS

- To qualify for this program's \$500 rebate, complete one of the following:
 - 1) Electri\$ense Energy Home Program To qualify for the rebate under this Program/Code, the following is required:
 - a. A qualified rater or inspector* must verify ALL the requirements on the attached checklist have been met unless not applicable.
 - b. Submit the completed checklist and this rebate form with Section 1 and Section 2 completed.
 - 2) <u>Electri\$ense New Home Program with blower door test in place of "Ductwork & Air Infiltration Control" Requirements.</u> To qualify for the rebate under this Program/Code, the following is required:
 - a. A qualified rater or inspector* must verify all requirements on the attached checklist have been met unless not applicable, except requirements in the "Ductwork & Air Infiltration Control" category.
 - b. A blower door test is required in place of the "Ductwork & Infiltration Control" requirements. Less than 3 air exchanges/hour at -50 Pascal is considered passing. The person performing the test must complete Section 3 of this rebate form.
 - c. Submit completed checklist and this rebate form with Sections 1,2, and 3 completed.
 - 3) 2020 Minnesota Energy Code To qualify for the rebate under this Program/Code, the following is required:
 - a. A Minnesota built home must meet the energy efficiency requirements of the 2020 Minnesota Energy Code.
 - b. Submit documentation showing compliance with the 2020 Minnesota Energy Code and this rebate form with Section 1 completed.
 - 4) A qualified rater/ inspector refers to a person who is knowledgeable in building standards, has experience in using blower door test equipment, if blower door test is performed, and is approved by your electric cooperative.
- New Home or multi-family dwelling must be on cooperative's lines and must be submitted not later than 3 months after certification.
- For multi-family dwellings, each structure may receive only one \$500 rebate, and the person requesting the rebate must be the owner of the structure and must be a member of the cooperative.
- · Rebates are in place through December 31, 2025, or until funds are depleted. Members are encouraged to submit as soon as possible.
- Rebates submitted after December 31, 2025, will not qualify if the rebate is no longer offered in 2026.
- Program is subject to change or cancellation without notice. Additional eligibility criteria may apply.
- One of the above rebate qualifying actions must have been completed.
- Required documentation listed below must be submitted no later than 3 months after certification.
