ELECTRIC WATER HEATERS

ELIGIBILITY AND INSTRUCTIONS

- Water Heater rebate **must be submitted no later than 3 months after purchase date** and must be installed on cooperative's lines.
 - Rebate not to exceed cost of high-efficiency equipment.
 - Installed equipment must be enrolled in the cooperative's Load Control Program.
 - Rebates are in place through December 31, 2025, or until funds are depleted. Members are encouraged to submit as soon as possible.
 - Rebates submitted after December 31, 2025, will not qualify if the rebate is no longer offered in 2026.
 - Additional eligibility criteria may apply. Contact the cooperative for details. The program is subject to change or cancellation without notice.
 - Required documentation listed below **must be submitted no later than 3 months after purchase date of water heater**.

 ✓ **A dated copy of your receipt or invoice for each item, unless purchased from FMEC.**
