NOTE: Agricultural, Commercial, and Industrial member that incorporate specific energy efficient equipment no listed below may qualify for a custom rebate. New and existing facilities are eligible. Contact cooperative for details.

- Equipment rebate(s) must be **submitted no later than 3 months after purchase date** and must be installed on the cooperative's lines.
- Rebates are in place through December 31, 2026, or until funds are depleted. Members are encouraged to submit as soon as possible.
- Rebates submitted after December 31, 2026, will not qualify if the rebate is no longer offered in 2027.
- Rebate not to exceed cost of equipment.
- Additional eligibility criteria may apply. Contact cooperative for details. The program is subject to change or cancellation without notice.
- Required documentation listed below must **be submitted no later than 3 months after purchase date**.
 - ✓ **Submit this rebate form.**
 - ✓ **A dated copy of your receipt or invoice for each item purchased.**
 - ✓ **Documentation showing the equipment has been installed**
