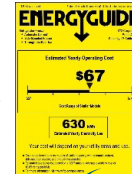


APPLIANCES & APPLIANCE RECYCLING

ELIGIBILITY AND INSTRUCTIONS

- **Appliance rebates must be submitted no later than 3 months** after purchase and must be installed on the cooperative's lines.
- Rebates are in place through December 31, 2026, or until funds are depleted. Members are encouraged to submit as soon as possible.
- Rebates submitted after December 31, 2026, will not qualify if the rebate is no longer offered in 2027.
- Additional eligibility criteria may apply. Contact cooperative for details. The program is subject to change or cancellation without notice.
- Required documentation listed below **must be submitted no later than 3 months after purchase date.**
 - ✓ **Submit this rebate form.**
 - ✓ **A dated copy of your receipt or invoice for each item purchased or recycled.**
 - ✓ **ENERGY STAR label for each item purchased- Except Inductive Range/Built-In Cooktops.**
