ELIGIBILITY & INSTRUCTIONS

- New Equipment rebate(s) must be installed on cooperative's lines.
- Rebates are in place through December 31, 2026, or until funds are depleted. Members are encouraged to submit as soon as possible.
- Rebates submitted after December 31, 2026, will not qualify if the rebate is no longer offered in 2027.
- If the heat pump has a variable speed blower motor, the air source heat pump qualifies for a rebate but not the variable speed blower motor.
- HVAC rebates cap at \$20,000 per consumer-member account per year.
- Rebate not to exceed the cost of equipment. Additional eligibility criteria may apply. Contact Freeborn Mower Electric Cooperative for details.
- Required documentation listed below **must be submitted no later than 3 months after purchase date.**
 - ✓ **Submit this rebate form.**
 - ✓ **A dated copy of your receipt or invoice for each item purchased. Note: Proposals are not accepted.**
 - ✓ **AHRI Certificate, for all Air Conditioners, Heat Pumps, and ECM Blower Motors**
 - ✓ **Documentation showing equipment has been installed.**
