SAFETY IS JOB #1

Attention to safety is always a priority at FMEC, as evidenced by frequent employee trainings and daily tailgate procedural reviews held by our outdoor crews.

In late June, our employees participated in fire extinguisher training. Learning and practicing how to properly use fire extinguishers can reduce panic and save precious time during a fire emergency.

When working with energized power lines, our workers must have faith and trust in their fellow employees to be able to react quickly. After all, their lives are literally on the line. Lineworkers must be able to rescue their fellow employees in any emergency situation. #2107205 In case of accidental contact with an energized power line, a lineworker must be able to perform a pole-top rescue and deliver appropriate first aid. Our crews were trained and tested on these procedures on June 22.

DAIRYLAND POWER PURSUES NEW FUNDING PROGRAM

Electric energy creates possibility and innovation.

Today's electric cooperatives are providing a path toward a more diverse and sustainable future, including the energy needed to electrify vehicles and other components of modern living.

The U.S. Department of Agriculture — Rural Development has launched a new tool available exclusively to rural electric cooperatives. The Empowering Rural America (New ERA) program is a \$9.7 billion program that is part of the Inflation Reduction Act and represents the largest investment in rural electrification since President Franklin Delano Roosevelt signed the Rural Electrification Act into law in 1936.

We are excited for Freeborn Mower Electric Cooperative (FMEC) to join wholesale power provider Dairyland Power Cooperative in utilizing this new funding rule as

we work to advance the clean energy transition without negatively affecting reliability or affordability. Dairyland Power is currently evaluating a portfolio of clean energy projects, including renewable energy and energy storage, to potentially include in our grant application for funding this summer. New ERA grant applications will be scored and ranked on the greatest reduction in the cost-per-unit measure of greenhouse gases. Projects must be reliable, financially and technically feasible, resilient, and affordable. New ERA creates opportunities for rural electric cooperatives of all sizes while ensuring that the cooperatives compete only against their peers of similar size. All projects must be completed and verified by September 30, 2031.

We will provide updates on project plans as they become available.



HELP HOLD DOWN WHOLESALE POWER COSTS

HERE'S HOW: The cost for Freeborn Mower Electric Cooperative to purchase wholesale electricity is directly tied to the highest aggregate level of electrical demand occurring during peak demand times. #1207001 Efforts to hold down the demand related component of the cooperative's wholesale power bill will help stabilize the retail rates to cooperative members. That's why we urge our members to "do the summer shift."

When possible, please AVOID EXCESS ELECTRIC USE during these peak hours of demand, especially on extremely hot days:

Weekdays between 11:00 a.m. to 7 p.m.

Shift your use of these to early morning hours or later evenings:

- Dishwasher
- Clothes washer and dryer
- Over
- Dehumidifier (put it on a timer)
- Pool Pumps (shut off when not in use)
- Use cool/warm water instead of hot.

Specifications and electrical codes are constantly changing, and it's our job to help you stay in compliance with the necessary requirements. Please contact our office to assist in your business or home electric service upgrade or relocation process. #292104 House or building moves that require the involvement of Freeborn Mower Electric Cooperative crews require an advance notice of at least two weeks, the moving route, the height when loaded, and a down payment. To schedule a move, upgrade in service or relocation, please contact our office.

Because the human body is made up of about 70% water, we are good conductors of electricity. Electricity will always find the easiest path to the earth or ground. Should that path be through the body, accidental electric contact can be deadly or cause painful internal burns that are extremely difficult to heal.

BABIES AND TODDLERS

- Keep charging cords unplugged when not in use and away from curious children who may put them in the mouth, loosen them from the outlet, or twist to prevent a choking hazard.
- Baby-proof exposed outlets with socket covers.
- Never let them stick fingers or other objects into electrical outlets or a light bulb receptacle.

YOUNG CHILDREN

- Warn them to never use any electrical devices near the sink, bathtub, or swimming pool.
- Teach them to always have dry hands before touching an electrical device. The same goes for not standing in water or puddles and using anything that is electrical.
- Cords should only be disconnected by pulling on the plug, never the cord.

ALL AGES

- Unplug the appliance or electrical device when cleaning it.
- Never use worn or damaged cords. Replace them immediately.
- Grounded electric plugs require all three prongs. Never remove the third grounding prong to make it fit an outlet.
- Do not throw materials of any kind or tied shoes on electric powerlines. Never try to remove anything entangled in a powerline.
- Electric substations are strictly off limits, as are underground powerline transformers and junction boxes. Stay away!
- Electrical equipment of all types should never be used for target practice or be the target of vandalism.
- Never touch or even go near any broken powerlines or wires on the ground. #292104 They could still be energized!
- Never fly kites, remote controlled airplanes, helicopters, and drones near powerlines.

Grants awarded for the second quarter of 2023 totaled \$25,494.97 and benefited 42 organizations! That's an infusion of real money into our local communities — Operation Round Up® makes a significant impact!

Operation Round Up® is a voluntary, opt-out program. Members' electric bills are rounded up to the next whole dollar amount. This creates a tax-deductible donation that is pooled into the Operation Round Up® fund, which is overseen by a separate board of trustees. This money is never mingled with the cooperative's funds. #1207001 The trustees review applications and grant awards on a quarterly basis. CUCUMBER LEMONADE Submitted By: Becky Bias

- 5 med cucumbers, peeled and cut
- 2 1/2 cups water
- 1/3 C + 2 Tbsp lemon juice
- 4 Tbsp sugar

Directions:

Place cucumbers in blender, add 1½ C water, blend well, and strain. Return strained liquid to blender, add 1 C water, lemon juice, and sugar blend together. Add more sugar if you prefer. Chill and serve. Yields approximately 32 oz.
