### **FOCUS ON THE FUTURE GRID**

Freeborn Mower Electric Cooperative (FMEC) owns and operates its local electric distribution system, providing retail electric services to its member-owners. Of course, our ability to do so depends on a much broader network of interconnected utility infrastructure that spreads across the region, from state to state, across the nation, and also into Canada. Not only are there interconnections of equipment, transmission and distribution power lines, and generation plants, the various business entities involved must coordinate and work together. Massive, technological, mechanical, and essential — we refer to this as the electric grid.

America's electric cooperatives cover about 56% of the nation's land mass and provide power to more than 21.5 million businesses, homes, schools, and farms in 48 states. So, you might wonder who is monitoring the grid and #1450200 preparing it to meet the needs of electric cooperative members, like those of FMEC?

The national service organization representing America's electric cooperatives is the National Rural Electric Cooperative Association (NRECA). An offshoot not-for-profit entity, NRECA Research, is working to develop and demonstrate new

technical capabilities that directly address challenges and opportunities of the electric grid in the future.

NRECA Research leverages extensive internal expertise and established industry partnerships in this quest. It envisions the future and anticipates the challenges our cooperative members may face and solves them with applied science and engineering. The entity's work aims to support decision-making and the application of solutions that result in affordable power delivered across a reliable and resilient electric grid.

The mission of NRECA Research focuses on four strategic concentrations:

- ENERGY SECTOR CYBERSECURITY for a secure present and future electric grid.
- UTILITY DATA ANALYTICS for the data-driven and analytic grid.
- SENSOR AND CONTROL NETWORKS for the integrated grid.
- EQUITY AND ENERGY ACCESS for fair, equitable use of the grid.




### ESSENTIALS FOR SUCCESSFUL GOVERNANCE

### **COLD WEATHER RULE REMINDER**

Freeborn Mower Electric Cooperative members who may have trouble paying their winter energy bills are reminded the Cold Weather Rule is in effect from October 1 through April 30.

If you are unable to pay your electric bill by the due date, you must contact our office to arrange a payment plan. Your service may be discontinued, even during the winter months if you fail to respond to the disconnect notice.



There is still time to take steps to reduce your home energy consumption this winter.

As we spend more time indoors and heating systems work overtime during the wintertime, Minnesotans consume a great amount of electricity. We also tend to use our ovens more often and turn to using auxiliary heaters. Reduce wasted energy by following these suggestions.

- **1. MAINTAIN HEATING EQUIPMENT** Replace dirty clogged filters and have the equipment inspected for necessary maintenance.
- 2. **REMOVE ITEMS BLOCKING VENTS** Avoid blocking heating ducts/vents and cold air returns. This will help your equipment operate properly and add to your indoor comfort.
- **3. LOWER THE THERMOSTAT** Adjust your thermostat to the lowest comfortable setting. Start with a setting of 68 degrees.
- **4. MAKE YOURSELF COMFORTABLE** Rather than turning up the thermostat setting, try a heated blanket to keep you cozy while seated.
- 5. ELIMINATE DRAFTS AND AIR LEAKS Seal air leaks and drafts around windows and exterior doors. Kits are available for blocking air leaks from outlets and switch plates that are situated on exterior walls. Consult with a hardware store representative to determine the proper products.
- **6. CONSERVE WHILE COOKING** Bake multiple dishes simultaneously. For quick tasks, using a microwave or toaster oven will use significantly less energy than a large oven.
- 7. MAKE USE OF RESIDUAL HEAT If you have multiple loads of laundry to dry, do them in quick succession, that way you'll make use of residual heat from the prior load. You can also leave the oven door ajar when finished baking to allow residual heat into your living space.
- 8. UNPLUG WHEN POSSIBLE Turn off unnecessary lights and electronics when not in use. Standby lights are telltale signs that electricity is slowly being consumed although the device is not in use. Turn off your home lights and check to see how many small standby lights remain lit. The only way to ensure that electricity is not being consumed is to unplug the device until needed. This works best, of course, with devices used infrequently.

If you rely on space heaters or heating tapes, make sure they are installed properly. Keep space heaters away from all flammable items. Place them in areas where they will not become a tripping hazard and never place the electric cord under a rug.

## ELECTRIC LINEWORKER SCHOLARSHIPS

Two applicants pursuing post-secondary education in an Electric Lineworker Program will each be awarded a scholarship for \$1,000, payable in two payments. Electrical lineworkers install, maintain, and restore electric power lines.

### **ELIGIBILITY REQUIREMENTS ARE:**

- Recipients must be enrolled in an Electric Lineworker Program
  to begin in the fall of the current year. In the event the lineworker
  program is full and the college of choice is maintaining a student
  waiting list, the recipient must provide proof in writing in order
  to hold funds for the next open enrollment period.
- The student must successfully complete the first semester with a grade point average of at least 2.5 on a 4.0 scale to be awarded the second half of the scholarship funds.
- Preference will be given to Freeborn Mower Electric Cooperative members and residents of Freeborn and Mower counties.
- Selection criteria will be based on scholastic achievement, school #1358101 and community involvement, work history, and an essay submission.

As Minnesota and the nation continue to transition to renewable forms of energy, the home solar industry has been growing. "There have been advances in solar technology and equipment in recent times," notes Bryan Skogheim, FMEC Director of Energy Solutions. "Tax credits and declining equipment costs create additional incentives for installing a solar energy system at your residence."

If you are interested in residential solar, FMEC suggests the initial step is to get an energy audit and make any indicated basic energy efficiency upgrades. #353803 By first making your home as energy efficient as possible, you've reduced your overall energy demand. This decreases the size of solar system investment and will maximize the energy-saving returns.

Examine how you'll use solar energy. Will you use it to generate electricity, heat water, or help heat your home? Is your location suitable for solar? Are there any restrictive covenants in your neighborhood or community?

"There are many solar resources available. The Minnesota Department of Commerce website has links to several sources of information," adds Skogheim. "FMEC is also here to help. Before you invest, please contact our cooperative so we can review the interconnection that will be made with our distribution system. Additionally, research reputable installation companies, product warranties, and financing."

### **BEEF SOUP**

### **Submitted By: Sharon Hanson**

- 1 lb. hamburger
- 1/2 C. each of celery and carrots, chopped
- 1 garlic clove, minced
- 1 quart whole tomatoes
- 1 can undrained kidney beans

- 5 Tsp. beef bullion
- +4 C. water
- 1/4 Tsp. parsley, oregano, basil, & pepper
- 2 C. cabbage cut
- 1 C. green beans
- 1/2 C. macaroni

#### **Directions:**

Brown hamburger, drain, add all ingredients except cabbage, beans, & macaroni. Simmer 20 min. and then add the rest of the ingredients. Cook until tender, another 10 min. or so. It can be served with parmesan cheese.
