## **OUR PART OF THE GRID**

The system that delivers your electricity is often described as the most complex machine in the world, and it's known as the electric grid.

We all use different amounts of electricity throughout the day, so the supply and demand for electricity constantly fluctuate. Most households use more electricity in the mornings when we are starting our day, and also in the evenings when we're cooking dinner and using appliances. Severe weather and other factors also influence the amount of electricity consumed.

The electric grid is a network of utility infrastructure — generation facilities, transmission lines, substations, transformers, distribution power lines, and various other electric equipment. What role does FMEC play in the grid? We are a distribution cooperative, so our role in the grid network is to provide local electric service. Additionally, FMEC and 23 other electric cooperatives own the electric power generating and transmission source, Dairyland Power Cooperative.

The first challenge for electric providers is to plan for, produce, and purchase enough electricity so it will be available exactly when we need it. #534703 The next two challenges are to transmit this electricity and then distribute it to the end-user. For the whole system to stay balanced, the electric grid must adjust in real-time to changing demand and unforeseen events.

While our focus is local to southern Minnesota, on behalf of our board of directors I assure you that we also keep abreast of statewide and national energy issues, the changing regulatory environment, emerging technologies, and energy consumption trends.

Our goal is to make sure that you have access to all of the electricity you need, when you need it. FMEC is proud to be your trusted, locally controlled, and member-owned energy provider.

## **HOW ELECTRICITY GETS TO YOU**



# step 1 **Generation**

Electricity is generated from various sources.



#### step 2

**Step-Up Transformer**Voltage is increased to push the electricity over long distances.



#### step 3

**Transmission Power Lines**Lines carry electricity over long distances.



#### step 4

**Transmission Substation**Voltage is lowered so electricity can travel across the local system.



#### step 5

**Distribution Substation**Voltage is lowered further for safe distribution.



#### step 6

**Distribution Power Lines** Electricity travels across these lines in your community.



## step 7 Final Stop

A transformer reduces voltage a final time, and electricity is sent to your home.



# From the time it's created to the time it's used, electricity travels great distances to be available at the flip of a switch. That's what makes the electric grid our nation's most complex machine- and one of our nation's greatest achievements.

# UPGRADE FOR ENERGY EFFICIENCY



Is it time to replace a household appliance or HVAC equipment? FMEC offers a variety of rebates to incentivize the purchase and installation of energy-efficient lighting, appliances, and equipment.

"LED lighting rebates are available again in 2024," explained Bryan Skogheim, Director of Business Development & Energy Solutions. "However, there are some changes to our rebate program this year. Complete rebate information for 2024 is posted on our website or available from our Energy Solutions Department."

#### **THE CHANGES ARE:**

- The Electric \$ense New Home requirements are updated from the 2015 Energy Code to the 2020 Energy Code.
- The \$25 Smart WIFI Thermostat incentive now requires the thermostat to be a Honeywell® or Emerson brand which must be enrolled in the FMEC load management program.
- Air Conditioning and Heat Pump rebate requirements include new SEER2 requirements.
- Central Air Conditioning qualification SEER ratings have increased from 16 SEER or 15.3 SEER2 to 19 SEER or 18.1 SEER2.
- The Heat Pump Water Heater UEF factor will be a minimum value of 2.2.
- Due to low participation, the solar water heater rebate has been discontinued.

Additionally, FMEC provides funding to SEMCAC for low-income members to utilize SEMCAC for energy-efficient upgrades and incentives.

#### POST FILING DEADLINE FOR NOMINATION BY PETITION

After the December filing deadline has expired, persons may still be nominated by filing a petition form that is available from the FMEC office. #1877200 To become a nominee by petition requires fifteen (15) members from the district in which the election is being held to sign in support of a particular nominee on the petition form. The petition form must be submitted to the cooperative office by 3:30 p.m. on Wednesday, January 17, 2024.

#### WHEN THERE IS A SINGLE NOMINEE

Should only one nominee come forward in the district by the Nominee by Petition deadline, that applicant will be deemed elected as Director.

#### WHEN THERE ARE MULTIPLE NOMINEES

Should multiple names be filed in a particular district, a biography of each nominee will be sent to all members of the district on Wednesday, January 31, 2024. Returned ballots are due on Monday, February 19, 2024. Ballots must be returned in the provided envelope to the third-party balloting company and not to our cooperative. Allow for possible mail delays.

# WORKING THROUGH WINTER'S CHILL

Our Operations Department employees work diligently all year round, even in the harshest weather conditions. However, the frozen ground makes it difficult to install underground cables, so we delay this task until spring. #534703 Nonetheless, plenty of work is still suitable for the winter months. During this period, our underground installation crews shift gears to focus on fleet maintenance and tree trimming.

"Keeping our fleet of cable plows, backhoe, and directional drilling machine take significant maintenance in the off-season to ensure maximum uptime during the winter months," explained Al Stadheim, PE, Director of Engineering and Operations. "The line crews that work primarily with the underground construction also transition to maintenance work on the overhead system during the winter months. This work includes changing out poles, conducting line patrols to locate areas in need of repairs, and locating various overhead equipment that needs to be taken out of service periodically for required inspection and repair."

Winter is also when Freeborn Mower Electric Cooperative focuses on completing required annual trainings for our outside crews. Trainings are usually held on the most inclement of winter days. "These trainings include CPR/First Aid, oil spill and hazmat, forklift certification, and many other OSHA-required classes. Crews also must perform annual testing and certification on many types of tools and specialty equipment used every day in the field."







#### TREE TRIMMING FOR RELIABILITY AND SAFETY



We trim trees to keep branches from contacting or falling across power lines. This is an important activity because it helps reduce outages, whether they are momentary "blinks" or for extended periods.

Interference from tree branches is a frequent cause of power outages, especially following high winds, ice, and heavy snowfalls. This is why Freeborn Mower Electric Cooperative takes proactive measures and uses a systematic approach to make sure that right-of-ways are free from potential hazards.

If you see our tree-trimming crews working along the roadside, please slow down and give them plenty of space to work safely.

## **IMPOSSIBLE QUICHE**

**Submitted By: Leola Anderson** 

- 12 slices bacon, crisp & crumbled
- 1 cup (4 oz.) shredded Swiss cheese
- 1/4 cup finely chopped onion
- 2 cups milk
- 1/2 cup Bisquick
- 4 eggs
- 1/4 teaspoon salt
- 1/8 teaspoon pepper

#### **Directions:**

Preheat oven to 350°F (325°F for glass). Grease a 9-inch pie plate or square cake pan. Mix bacon, cheese, and onion; spread in the prepared dish. In another bowl, blend milk, Bisquick, eggs, salt, and pepper until smooth. Pour over bacon mixture evenly. Bake for 55 minutes until slightly browned and a knife comes out clean. Allow to stand for 5 minutes before serving.
