# COLD WEATHER RULE ENDS APRIL 30

*Minnesota's Cold Weather Rule protects residential utility customers from having electric service shut off between October 1 and April 30.* If your account is past due, you are no longer protected under the Cold Weather Rule after April 30th. If you need to make a payment arrangement on your account, please contact our office during normal business hours.

Collection of all reconnection fees will resume May 1, 2022. If your electric service is disconnected for non-payment, the entire past due balance, \$100 reconnect fee, and deposit equal to two times the average monthly electric bill may apply. All fees must be paid in full to be reconnected.



#### Here's what you need to know.

## SELLER RESPONSIBILITY

- The selling member needs to contact FMEC office by calling or coming into the office.
- The account must be listed in your name to request a transfer of service. FMEC will ask for personal verification information of caller.
- The seller will be asked to provide date of closing and buyer's name, if available. We may also ask for realtor information, if applicable. FMEC will verify this information matches with the information received from the buyer.
- If the buyer hasn't already contacted us, FMEC will attempt to contact the buyer to discuss the transfer process.
- If a deposit is on the account, it will be applied to the seller's final bill, and any remaining credit will be transferred to an active account under the same membership or returned in the form of a check.

## **BUYER RESPONSIBILITY**

- The buyer needs to contact FMEC by calling or coming into the office.
- An application will need to be filled out, completely, including names, phone numbers, email addresses, mailing address, social security numbers, and dates of birth.
- A soft credit check will be performed and a deposit may be required depending on the results of the soft credit check. (A soft credit check does not affect your credit score). A deposit will be credited to the member's account after the required deposit is paid in full, followed by twelve consecutive months of ontime payments or upon termination of service. Confirmation of closing date is required and it must match the date the seller has provided.

# **VEGETATION MANAGEMENT**

# SAFETY AND SERVICE RELIABILITY

We understand that many people are rather protective of their trees. Freeborn Mower Electric Cooperative also appreciates trees for all their intrinsic values, but we also recognize that trees have a proper place. That place is not within the power line right-of-way corridors. We clear trees and vegetation from power line rights-ofway because:

- Power outages are frequently caused by trees or branches contacting overhead power lines. These outages can range from momentary blinks to a lengthy outage that impacts numerous accounts. Service quality and reliability depends on proper vegetation management.
- A tree that is in close proximity to a power line poses a lethal threat to anything that could climb it and contact an energized power line. This could be an adult, a child, or an animal. The result may be a tragic fatality. Public safety depends on utility vegetation management.
- Power lines contacting tree branches can spark fires that guickly spread out of control.

"Freeborn Mower Electric Cooperative employs a professionally trained three-man tree trimming crew year around, in addition to three two-man crews from Asplundh Tree Experts. #2281600 These crews follow a scheduled four-year rotational cycle across our service territory, determined by substation and circuit," stated Larry Underdahl, Manager of Distribution Maintenance. "I urge that homeowners never hire a private tree contractor to work within 10 feet of power lines or attempt to do the work themselves. Please contact the

cooperative so we can trim or take down the hazardous tree in a safe manner."

Although easements often give electric utilities the right to prune or remove any tree that interferes with the maintenance of electric lines, as a courtesy to our members, our tree care professionals will first notify the property owner in person or by door card.


"There are situations where tree removal is preferable to trimming. There are certain tall or fast-growing species that should never be planted under a power line. Trimming these species will never result in a natural looking tree, either. Saplings and brush can cause problems of access to power lines and utility equipment," explained Underdahl. "Trees that are leaning, are split, or hollow also pose safety and service reliability threats."

If you see a tree touching power lines and sparking, or another hazardous tree condition, please contact Freeborn Mower Electric Cooperative immediately.

# PLAN AHEAD BEFORE PLANTING

Freeborn Mower Electric Cooperative (FMEC) recommends th following guidelines when planting trees and shrubs:

- Trees that grow no taller than 40 feet may be planted 40 feet from electrical wires, not any closer.
- Trees that grow taller than 40 feet must be planted no closer than 50 feet from electrical wires and no closer the 35 feet from buildings, to allow proper root developmen while minimizing root damage to building foundations.
- FMEC maintains a 10 foot right-of-way clearance on eith side of an overhead power line.



# NOTIFY US NOW OF YOUR CONSTRUCTION OR EXPANSION PLANS

Freeborn Mower Electric Cooperative always strives to meet our members' expectations. That's why we need to be aware of your 2022 construction or expansion plans as soon as possible. Not only do we need to get your project on our construction calendar, but necessary equipment must also be ordered and there may be delays in this respect.

Rural Electric Supply Cooperative (RESCO) is the primary supplier of parts and components used by electric distribution and transmission cooperatives in nine Midwestern States. It has recently issued some warnings regarding supply chain concerns. It urged its member cooperatives, including Freeborn Mower Electric Cooperative, to plan for cost increases and parts shortages lingering into 2023. Among the essential components most affected are transformers.

# **BEING PROACTIVE IS FIRST LINE OF DEFENSE**

As much as we are anxious to get out and enjoy warmer temperatures, there are a few tasks that are important to tackle this time of year.



# SUMP PUMP

- Flooding will damage basement walls and furnishings, possessions, and even threaten the structural integrity of your house. Your sump pump is the first line of defense, but only if it is functioning properly. It should be inspected now, as melting snow and heavy spring rains can easily raise the ground water level. If water seeps into your house, you may be dealing with a costly mess.
- Make sure your sump pump is plugged into a GFCI (ground fault circuit interrupter) outlet for safety.
- Remove the sump pump lid and check for debris or any worn parts. Remove sand and debris from the pit.
- If you notice rust or rotten, moldy smells it may be time to replace the sump pump.
- To test the sump pump, slowly pour a bucket of water into the pit. #261308 The sump pump should automatically start when it reaches a certain level. If it doesn't start, it may need to be replaced.
- A fully charged back-up battery will be necessary during a power outage.
- Check with your local plumber if you have questions or concerns about your sump pump.



# **CENTRAL AIR CONDITIONING**

Is your equipment ready to tackle summer's heat and humidity? Beat the summer rush. Now is the time to ask your local HVAC (Heating, Ventilation, and Air Conditioning) service technician for an inspection!

Your service technician should:

- check refrigerant levels
- look for refrigerant leaks •
- check and seal any air duct leaks
- measure airflow through the evaporator coil
- verify that electric controls are functioning, including the accuracy of the thermostat
- check for any other needed maintenance

A dirty air filter will slow down the flow of air and reduce the unit's efficiency by as much as 5 percent to 15 percent, according to the U.S. Department of Energy. Consider replacing the air filter every three months.

If you are purchasing a new air conditioning unit, make sure it's ENERGY STAR certified for the best energy efficiency. HVAC rebates are available! We also offer rebates for AC Tune Ups. Check the REBATES tab on our website, or contact our office for details.

# OVERNIGHT OVEN BAKED WILD RICE Submitted By: Barb Lysne

#### **Ingredients:**

1 C. uncooked wild rice 3 C. boiling water 1 bouillon cube
