### Celebrating October as Co-op Month

October is an eventful month filled with harvest, school, and community activities in full swing. It's also when cooperatives of all types celebrate National Co-op Month.

When Freeborn Mower Electric Cooperative (FMEC) celebrates Coop Month, we are celebrating the foundations of the cooperative, its members, and the cooperative difference. In short, we are focused on serving our members with integrity and respect, while energizing their lives and communities. Similar to how our wires run through our service territory, our concern for community flows through all of our decisions because being a coop means being a responsible partner and good neighbor.

### CAPITAL CREDITS — A BENEFIT OF MEMBERSHIP

Capital Credits represent member equity in FMEC, a business that is member-owned and member-controlled. As you pay your electric bills, FMEC tracks your electric consumption and the patronage revenue received from your account. #252000 If the cooperative has generated excess margins (known as "profit" in other forms of business), the amount is allocated to the members

based on their electric consumption.

Capital Credits are important to ensuring the financial health of the cooperative while also allowing its operation as a not-for-profit entity. Each year, the board of directors determines whether the cooperative's financial position will allow for the return of Capital Credits, what we call "retirement", and if so, the amount to be retired. Prior to their retirement, this money has been put to work within the cooperative, reducing the need to borrow funds.

### FMEC TO RETIRE \$849,294 IN CAPITAL CREDITS

Your board of directors recently approved the 2022 general retirement of \$849,294 in Capital Credits. The retirement of Capital Credits is a tangible expression of "the cooperative difference." Capital Credits are applied to the October bills of qualifying FMEC members as a bill credit\*.

A check will be issued to former FMEC members should they be eligible to receive the disbursement of Capital Credits.

'If a Capital Credit refund is more than \$500, a check will be issued.



### **KEEP CONTACT INFORMATION CURRENT**

A member who terminates service with FMEC no longer receives additional Capital Credit allocations. However, the balance in the member's account will remain until it has been retired in full. Therefore, it is important that former members notify FMEC of any address changes until their account is depleted. In the case of a member's death, Capital Credits become part of the deceased member's estate.

## UNDER REVIEW AND CLOSE SCRUTINY

We are all aware of the nation's economic woes including inflationary pressures, supply chain delays, and uncertainty. The electric utility industry, on both the wholesale energy and retail delivery sides, has also been seriously impacted. The cost of energy is rising and while this is probably no surprise to you, it does impact the financial situation of FMEC. #88702 As a result, we've hired an outside professional consulting firm to make a detailed assessment of all of our expenses and how they are recovered through our retail rate structure.

Retail rates are broken down into two main components. The monthly **Service Charge** is meant to recover the actual operating expenses of FMEC. This includes all of the power line equipment, office-related expenses, depreciation, and so forth. It does not include the cost of the electricity consumed.

The **Energy Charge** is shown as a charge per kWh of electricity consumed. It reflects the actual cost of electricity. This includes the fuel and generation of electricity, as well as the transmission grid costs.

Our **Rate Study** is sorting out all of these expenses and matching them to their applicable area within our retail rate structure. This approach ensures fairness and equity in how our costs are recovered. Coupled with our local governance through a member-elected board of directors, equitable cost recovery is an important "cooperative difference." After all, we were built by the members we serve.

Wholesale power costs remain high and as a result, our retail PCA (Power Cost Adjustment) will track with these costs we are experiencing.



### MEMBER SURVEY THIS MONTH!

We will be conducting a member survey by email during October. If you are one of the members who has been randomly selected to participate, we would greatly appreciate your time and opinions about the cooperative. Your information and your responses will remain confidential. By participating in the survey, you will help us identify where we are serving you well and where we might need to improve. We will use the results to make decisions on matters important to the future of your cooperative and that benefit you, your family, and your neighbors.

In addition, as a thank you for your time, FMEC will hold a drawing for three \$100 bill credits. To enter this drawing, be sure to check "yes" at the end of the survey and provide your contact information. If you choose to be entered in the drawing, the co-op will know that you participated in the survey but will not see your responses linked to your name unless you indicate that you would like someone to contact you.

From time to time, FMEC holds events in which members can participate. Be sure to check "yes" in the appropriate area if you would like to be notified of these opportunities. Thank you for your honest feedback.

### WINTER STORAGE CONTROL SCHEDULE REVISED

There will be a slight revision in the electric heating storage control times beginning November 1, 2022.

Class 3 Daily Storage control will begin up to 30 minutes earlier than last year or continue up to 30 minutes later, but will be on a first in, first out basis. The control duration is 6.5 hours in the winter or 8 hours in the summer. The actual control durations remain the same as last year or perhaps may be decreased slightly. Expanding the gradual start of the control and restoration windows (ramp in, ramp out) will help reduce a cooperative's non-coincident peak as the control window ends.

### **NEW CONTROL WINDOWS:**

WINTER (6.5 HOURS)

- Morning random start from 5 to 6 a.m., with full restoral by 12:30 p.m.
- Afternoon random start from 3 to 4 p.m., with full restoral by 10:30 p.m.

### **SUMMER (8 HOURS)**

• Random start from noon to 1 p.m., with full restoral by 9 p.m.



## MEMBER GOVERNANCE — an essential "cooperative difference"

Freeborn Mower Electric Cooperative is governed by a nine-person board of directors. The directors are elected by their fellow FMEC members residing in the district. Elections are held in three districts each year, with each director elected to serve a three-year term.

### THREE DISTRICTS TO HOLD DIRECTOR ELECTIONS

Nominations are now open for interested members in the following Districts:

- **DISTRICT #3:** Represents areas northwest of Austin, Sargeant, Brownsdale, Nicolville, and Dexter.
- DISTRICT #6: Represents Hayward, Glenville, and areas west of Gordonsville.
- **DISTRICT #9:** Represents the northern part of the city of Albert Lea.

Nominees must meet all eligibility requirements as specified in the cooperative's Bylaws. Among the qualifications and responsibilities outlined in the Bylaws, nominees must be:

- 1. a current member receiving electric service at their primary
- 2. the primary residence must be in the district in which the director is elected.

### Install a programmable thermostat.

Programmable thermostats can make your heating (and cooling) system operate more efficiently. Why heat a home — or cool it for that matter — at the same temperature when no one is in it? Programmable thermostats are easy to install, and ENERGY STAR estimates you can save as much as 10% on heating and cooling costs by properly using one. Set it to the recommended temperatures and then just enjoy the savings.



### Check, clean, or replace central heating filters.

Check filters monthly and change them every three months, at least. A dirty air filter slows down air flow and makes a system work harder, thereby wasting energy.



### Replace or weatherstrip windows and doors.

Windows and doors top the list of culprits for air leaks that lower the energy efficiency of your house.



### Change ceiling fans to rotate the correct way.

Ceiling fans are not just for summer cooling. In the winter, they can also be used to rotate airflow so that heat rising into a high ceiling is blown back down toward the room's occupants. In the winter, the fan should spin clockwise. #88702 This redistribution of warm air makes a room feel warm and more comfortable, helping to save on heating costs. To change the rotation of the fan, use the toggle switch on the motor housing.



### Close the vents and doors to unused rooms.

Just make certain that no pipes are susceptible to freezing if the room is unheated for long periods of time.

### **COMPREHENSIVE IN-HOME ENERGY AUDITS AVAILABLE**

FMEC is partnering with Minnesota Energy Resources to help Albert Lea residents figure out what energy-saving improvements make the most sense for their homes.

Appointments are being scheduled for October 11-13. This service is valued at more than \$300, but the homeowner only pays \$50. To be eligible, the home must receive natural gas service from Minnesota Energy Resources and electric service from Freeborn Mower Electric Cooperative.

## COLD WEATHER RULE REMINDER

Freeborn Mower Electric Cooperative members who may have trouble paying their winter energy bills are reminded that the Cold Weather Rule took effect October 1.

If you are unable to pay your electric bill by the due date, you must contact our office, to arrange a payment plan. Your service may be disconnected, even during the winter months if you fail to respond to the disconnect notice.



## Residential Electric Heat Tax Exemption

Electricity sold to residential consumers who use electricity as their primary source of heat (50% or more) is exempt from sales tax for the billing months of November, December, January, February, March, and April. All electricity used through the same meter will be exempt for the same six-month period.

Freeborn Mower Electric Cooperative (FMEC) requires a signed certificate stating that your primary source of heat is electricity. The purposes of this certificate are: 1) It notifies FMEC to remove the sales tax from your bill for the qualifying months. 2) Should FMEC be audited by the Department of Revenue, FMEC would utilize the exemption certificate signed by you, as our authority to remove the sales tax. #252000 This is for the protection of the Cooperative. If FMEC were audited and it was found that the consumer's bill was illegally exempted, it would be the responsibility of the individual consumer to pay any amount.

Long hours, increased stress, tight schedules, and fatigue can make it tempting to take shortcuts as you bring in the crop. This can be extremely dangerous! It only takes a split second for someone to come into contact with electricity. The danger is real and could be deadly!

- Look up and look around! Start the day with a safety meeting. Review the need to keep ladders, augers, and all farm equipment far away from power lines for your safety and those working around you. The risk of electrocution around grain-handling equipment and storage areas is high.
- Plan your route. Remember that your equipment may be taller in transport than during field use. Know your clearances near your grain bins and overhead powerlines. Use a spotter to make sure a 10-foot clearance is maintained from overhead powerlines. Also, be aware of the location of power pole guy wires. Accidently pulling down a guy wire may break a pole or dislodge an energized power line.
- Train your team. It's harvest crunch time and everyone working on the farm must be ready for the task. Evaluate the jobs that you have tasked your harvest help with and ensure they are not taking on more responsibility than they are mentally, cognitively, and physically able to accomplish. Always provide training for youth or temporary workers prior to starting any work and check in with them at regular intervals, checking on their understanding of the process, their progress, and safety.
- Know how to exit safely. If your farm equipment does come in contact with a power line, remain seated until help arrives. Call 911! Many electrocutions occur when the operator dismounts

and lands incorrectly or tries to climb back on. Warn others to stay at least 50 feet away, and to not approach you or the tractor, combine, or truck. Should there be an immediate danger, like a fire, put your feet together and jump as far away as you can – keeping your feet together as you land and shuffling as you move away. #2181403 Do not allow any part of your body to contact the ground and electrified equipment at the same time.

- Affix a slow-moving vehicle sign and caution lights. Be aware that a majority of roadway accidents involving farm equipment happen at dawn and at dusk. A combination of low light conditions, peak traffic times for the public, farm machinery entering or exiting the fields, and slowly moving equipment can lead to danger.
- Shield from moving parts. Machinery
  entanglements are the leading cause of injury and
  death on the farm. Do everything you can do to
  prevent it including guarding or shielding all moving
  parts on machinery, and also keeping bystanders and
  children away. Components may continue to rotate
  for several minutes after the power is shut off. Don't
  open doors until all parts have stopped moving.
- **Designate a safe play area.** Make sure children are kept far away from moving farm equipment.

### DO NOT BURN NEAR UTILITY EQUIPMENT

If your autumn clean-up includes burning ditches, do not burn near the base of power poles or around underground electric utility boxes!

### **QUICK APPLE CRISP Submitted By: Debra Madson**

### **Ingredients:**

- 5 C. diced apples
- 1 C. brown sugar
- 34 C. oatmeal
- 34 C. flour
- ½ tsp. cinnamon
- ½ C. butter

#### **Directions:**

Mix all ingredients except for the apples together. Put diced apples in a 9 x 13 pan and sprinkle the mixture over the apples. Bake at 350 degrees for 45 minutes.
