## Freeborn Mower Operation Round Up Donates One Million Dollars

The Freeborn Mower Operation Round Up has announced it recently hit a one-million-dollar milestone.

The Freeborn Mower Operation Round Up program has awarded more than \$1,000,000 in grants to local community organizations since the start of the program in 2003.

Over the past 19 years, Freeborn Mower Operation Round Up has changed and grown and now awards grants to nonprofit organizations in Freeborn and Mower Counties for projects and events that benefit our communities.

Operation Round Up is a nonprofit program that is administered by a five-member board of trustees and operates separately from Freeborn Mower Electric Cooperative (FMEC). Recent organizations receiving grants have included fire departments, youth organizations, food banks, schools, museums, and libraries.

The Freeborn Mower Operation Round Up is an opt-out program. FMEC members' electric bills are automatically rounded up to the next nearest whole dollar amount. The monthly contribution could be as little as a penny but never more than ninety-nine cents. The average donation is approximately \$6.00 per year and is tax deductible.
