Our Operation Round-Up® Program is an *opt-out* program. This means members' electric bills are automatically rounded up to the next nearest whole dollar amount, unless you opt-out. The monthly contribution could be as little as a penny, but never more than ninety-nine cents. For example, a member's electric bill is \$81.75. The bill would be rounded up to \$82.00 and \$.25 would be deposited into the Operation Round Up® fund; a fund completely separate of the cooperative's funds. The average donation per member is approximately \$6.00 per year.

Contributions to Operation Round-Up® are tax-deductible and are printed on your electric bill each month with the total yearly contribution amount listed on your December electric bill.
